**Transfer of DC pensions savings from the DSV UK Group Pension Scheme to the Aviva Master Trust**

The transfer of accumulated Defined Contribution (DC) pension savings from the DSV UK Group Pension Scheme to the Aviva Master Trust was completed on 2 August 2023. Following the transfer Aviva issued welcome letters to the members included in the transfer along with login details to access their Aviva online account. As a reminder, this transfer was in relation to accumulated DC pension savings only and there will be no change to member's other benefits in the Scheme. If you have accrued any Defined Benefit (DB) pension in the Scheme this was not transferred to the Aviva Master Trust and will remain in the Scheme.

If you paid additional voluntary contributions ("AVCs") whilst accruing DB pension in the Scheme and have investments with the following providers there will be no changes to these investments, and these will also remain in the Scheme:

- Phoenix Life (DSV Group section)
- Standard Life (DSV GIL section)
- Royal London (DSV GIL section)

**Transfer of the DSV GIL Section DB pensions administration from Barnett Waddingham to Hymans Robertson LLP**

The Trustee appointed Hymans Robertson LLP to provide administration services for the DSV GIL Section of the Scheme from 4 September 2023.
